- 1 Journal paper publications must conform to the following:
 - A. Students enroll on Fall semester the submission date must be on or after August 1st of the year the student is admitted into the Ph.D program. Students enroll on Spring semester the submission date must be on or after February 1st of the year the student is admitted into the Ph.D program.
 - B. The paper must be published in the name of Department of Business Administration, National Central University, Taiwan/R.O.C.
 - C. The student must be first author(student's advisor is excluded) or corresponding author.
- 2 The research topic for applying Graduation Eligibility Evaluation threshold ought to relate with student's dissertation. Students must get approval from advisors and satisfy one of the following three requirements to propose defenses(including candidacy evaluation paper):
 - A. Publish at least one (1) paper written under the guidance of and co-authored with student advisor in a SSCI or SCIE journal and have completed 31 or more monthes of studies in Ph.D program.
 - B. Publish at least two (2) papers written under the guidance of and co-authored with student advisor in the journals in the field of management which are recommended by National Science and Technology Council, or in TSSCI/EI indexed journals, which should have an ISSN, and have completed six or more years of studies in Ph.D program.
 - C. For the group of financial management, publish at least one (1) paper written under the guidance of and co-authored with student advisor in a journal ranked above (including B+) in the list composed by National Science and Technology Council and have completed 31 or more monthes of studies in Ph.D program.
- 3 Students must publish a paper written under the guidance of and co-authored with student advisor in one of the following journal types to satisfy requirements for the Ph.D candidacy evaluation:
 - A in a SSCI or SCIE or ESCI or EI journal, which should have an ISSN.
 - B in the journals which are recommended by National Science and Technology Council.
 - C in a journal on the TSSCI list.
 - D in a domestic or foreign journal approved by each department section (allow to submit across sections) (see Addendum 1).

- Documentation of the publication process must be provided (including the letter sent to the journal when submitting a paper, reviewers' comments, revisions based on reviewers' comments, a letter of acceptance from the journal, a copy of the paper submitted, and a chart showing the division of labor of co-authored papers), and should expose posting fee and publication fee (not include editing fee).
- 5 For co-authored papers, only one student can count the publication towards his/her total publications or use it for applying for candidacy.
- 6 A list of approved journals for categories listed in Item 3 is revised and updated each May.

 This list is for use by new students that begin the program the following academic year.
- Students must document the nature and type of journal (i.e., SSCI, SCIE, TSSCI, etc.) when submitting a paper for publication. This information can be obtained from the journal's website or from inside the journal.
- 8 When applying for candidacy, students must provide proof that the journal published in is in line with these publication guidelines.
- 9 These guidelines go into effect after having being approved in a department meeting. The same holds true for revisions and corrections.
- 10 The above-mentioned guidelines are applicable to the students who enrolled after 99 Academic Year. If the students (enrolled before or including 110 Academic Year) submit the journal before Feb.28, 2022, both the guidelines 1C and 2 are no longer limited for them. Please note that the evidence of the submission date is necessary for the application of Graduation Eligibility Evaluation.
